महोदय /Sir,

Regional Transmission Account (RTA) for the month of August, 2017 was issued vide our letter of even no. dated 05.09.2017.

CERC vide order dated 4th January, 2017 in petition no. 155/MP/2016 and its corrigendum dated 06.03.2017, directed that NRPC shall include YTC details of the assets in RTA as provided by NLDC for bilateral billing due to non-availability of upstream/downstream system. It was also directed that the beneficiary Discom shall be liable to bear transmission charges from SCOD/actual commissioning whichever is later till commissioning of downstream system post which the assets shall be considered under POC.

NLDC vide e-mail dated 20.09.2017, has submitted Monthly Transmission Charges details of bilateral assests of POWERGRID Kala Amb Transmission Limited (PKATL) to NRPC, Secretariat.

In compliance to above mentioned CERC order, this addendum in RTA for the month of August, 2017, is being issued. The details of Monthly Transmission Charges and the beneficiary Discom, as provided by NLDC are enclosed herewith for information and necessary action.


