**Abstract of decisions taken in the 71st meeting of OCC held on 17th January, 2011
at NRPC Secretariat.**

1. Those utilities who have not submitted the over-voltage setting of various 400 kV/220 kV double circuit lines, shall submit the same within 10 days.
2. Peak demand during the month for preparing the Power Supply Position shall be worked out by adding (i) the quantum of load shedding (ii) power cuts and (iii) frequency correction at the time when peak demand is met.
3. POWERGRID (NR-I) to take up the issue of tuning of PSS at all generating stations with their corporate office.
4. Those utilities who have not submitted the details of operation of System Protection Scheme (SPS) during the tripping of HVDC bi-pole at 08.23 hrs on 04th December 2011, shall submit the same within 10 days. Further, all utilities will (i) log the counter reading everyday and (ii) POWERGRID shall investigate the reasons for non-receipt of signal at Muradnagar.
5. In respect of Loss of generation at Anpara TPS & Anpara-C TPS on 7th December 2011 at 20:25 hrs., UP SLDC will investigate the incident and submit the detailed report.
6. In respect of Loss of generation at Panipat TPS on 10th December 2011 at 00:24 hrs., Haryana SLDC will investigate the incident and submit the detailed report.
7. In respect of Multiple Tripping & Loss of generation in Punjab System on 22nd December, 2011 at 03:30 hrs., Punjab SLDC will investigate the incident and submit the detailed report.
8. For taking pollution measurement in the second week of February, 2012, POWERGRID will ensure that measuring instruments are made available to STUs by the first week of February, 2012.
9. In respect of adequate back-up power supply at wide band communication and its regular upkeep, all utilities would submit the requirement of Batteries to POWERGRID since the Batteries are 10 years old.
10. In respect of two logics for SPS that would take care of tripping of any line connecting NAPPs proposed by NRLDC and forwarded by NRPC Sectt. as well as NRLDC to UPPTCL, UPPTCL would furnish their written comments within 07 days.
11. Those utilities who have not nominated their representative to sub-committee constituted under SE(O), NRPC to review the quantum of loads to be shed through UFRs and their locations, would forward the nomination of their representative within 10 days.
12. All utilities to intimate any errors/ omissions in the list (enclosed) of new generating units (compiled by NLDC) which have been recently commissioned and are expected to be commissioned up to 2012-13 for the computation of Point of Connection Charges (2012-13), by 25.01.2012.
13. OCC approved the proposal of POWERGRID for replacement of porcelain insulators with polymer insulators on 12 Nos. lines in addition to lines already approved by NRPC.
14. NRLDC to send details to NRPC, Secretariat regarding non-functional 132kV link between Jammu & Kashmir regions for taking up the issue of its revival with PDD, J&K.
