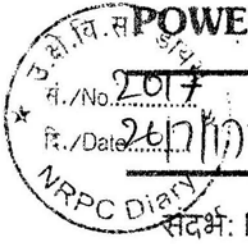

Sir,

As per Regulation 16 of the Sharing Regulations 2010 and subsequent amendments thereof, the Designated ISTS Customers (DICs) and Transmission Licensees are required to submit the data for New Transmission Assets, Yearly Transmission Charges, Forecast Injection and Withdrawal and Node-wise Injection/Withdrawal Data to the Implementing Agency for computation of PoC Charges & Losses for the Application period.

In line with the above provisions and to facilitate the computation of PoC Charges and Losses for the period October 2017 – December 2017, it is requested to furnish the following data to the Implementing Agency latest by 31st July, 2017:

1. Yearly Transmission Charges (As per Format I)
2. Technical Details of new Transmission elements and Generating Units which are expected to commence commercial operation during October 2017 – December 2017 (As per Format II)
3. Details of Long Term and Medium Term Access. (Format III(A))
4. Node-wise forecast maximum injection and withdrawal data. (Format III(B))
5. Maximum injection and withdrawal data for corresponding quarter of last three years. (Format III (C)).
